## Key investor information

This document provides you with key investor information about this Fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this Fund. You are advised to read it so you can make an informed decision about whether to invest.

## OBJECTIVES AND INVESTMENT POLICY

The objective of the Fund is to increase the value of your investment over the long term, by providing above-average returns with below-average volatility (changes in the value of your investment).

### Portfolio securities

Under normal conditions, the Fund mainly invests in shares of companies that are based in, operate in, or do significant business in Asia (excluding Japan). The Fund may invest up to 50% of assets in China A Shares, either through Shanghai-Hong Kong Stock Connect or through other means. The Fund may also invest in bank deposits and money market instruments.

The Fund may use derivatives to reduce its exposure to various investment risks (hedging) and for efficient portfolio management, but not to directly seek investment gains.

## RISK AND REWARD PROFILE



**Risk and Reward Profile:** The SRRRI (Synthetic Risk and Reward Indicator) demonstrates where the Fund ranks in terms of its potential risk and return. The higher the Fund's position on this scale, the greater possible reward, but also the greater risk of losing money.

The SRRRI rating above is based on medium-term volatility (actual or estimated variations in the Fund's share price over five years). Going forward, the Fund's actual volatility could be lower or higher, and its rated risk/reward level may be changed.

The Fund's risk level reflects the following:

- As a class, shares carry higher risks than bonds or money market investments.
- The Fund focuses on a single geographical region that tends to have above-average risks.

### We bring your attention to the fact that:

- Historical data used in calculating the SRRRI may not be a reliable indication of the future risk profile of the Fund.
- The risk indicator shown above is not guaranteed and it may shift over time. The lowest category does not mean a risk free investment.

### Investment process

The Fund is actively and discretionarily managed. The sub-fund is not managed in reference to an index.

The Fund is a multi-cap fund focusing on bottom up stock picking of listed companies having their operations in Asia excluding Japan and on the basis of ground due diligence and compelling valuations using a value-driven investment methodology.

You can buy and sell shares of the Fund on any business day in Luxembourg.

All income generated by share Class GP USD of the Fund is reinvested and included in the value of its shares.

Recommendation: This Fund may not be appropriate for investors who plan to withdraw their money within 7 years.

**ESG investment risk:** The fund uses ESG criteria and may underperform the broader equity market or other funds that do not use ESG criteria when selecting investments.

**Derivative risk:** the Fund uses derivatives. These are financial instruments whose values depend on the value of the underlying asset. Small price fluctuations in the underlying asset can result in large price changes in the derivative.

**Liquidity risk:** liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

**Counterparty risk:** the Fund enters into contracts with various counterparties. If a counterparty does not fulfil its obligations to the Fund (e.g. not paying an agreed amount or not delivering securities as agreed) the Fund can suffer a loss.

**Emerging markets risk:** emerging markets are more likely to experience political uncertainty and investments held in these countries may not have the same protection as those held in more developed countries.

**China A-Shares risk:** The Fund may be investing in China A-Shares via the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect which may entail additional clearing and settlement, regulatory, operational and counterparty risks.

**Management risk:** Portfolio management techniques that have worked well in normal market conditions could prove ineffective or detrimental during unusual conditions.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

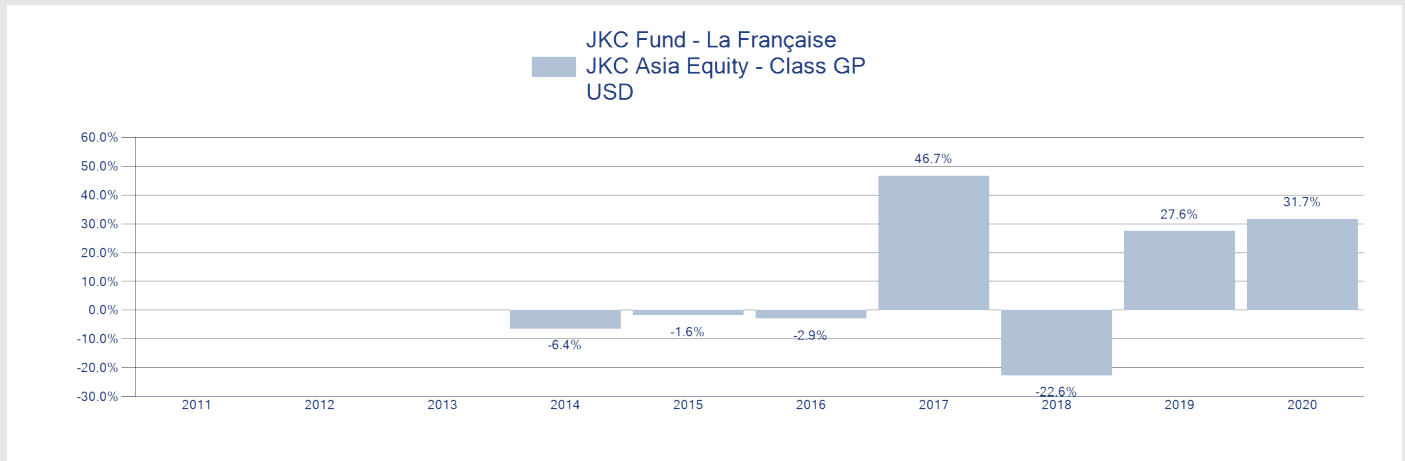
