## Investment strategy

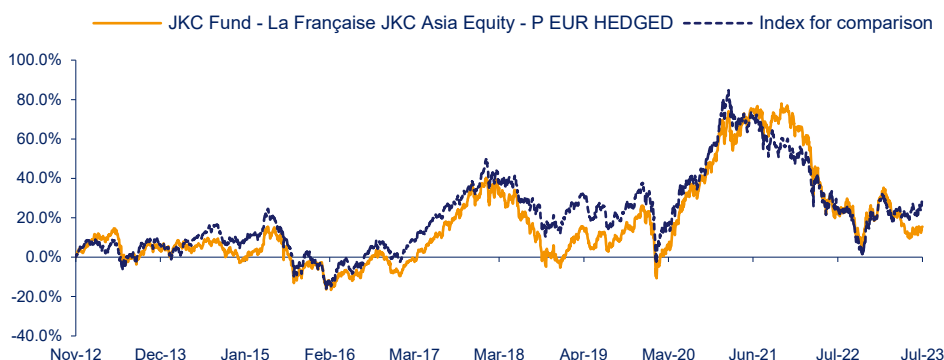

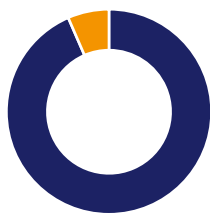

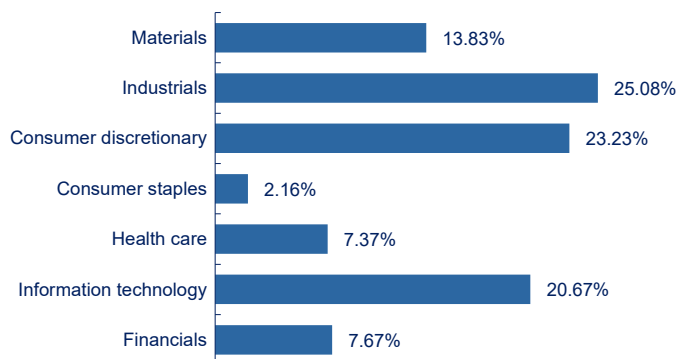

## Sector exposure (GICS classification)

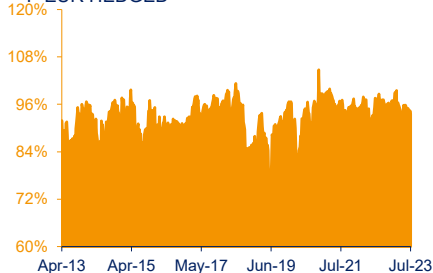

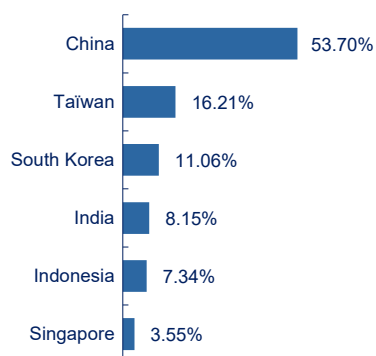

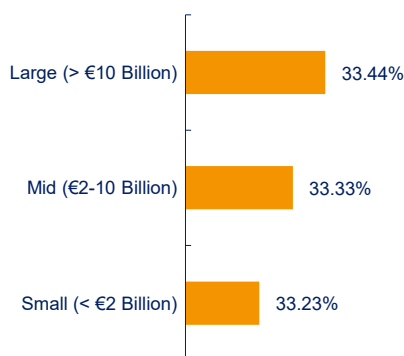
## Geographical breakdown
