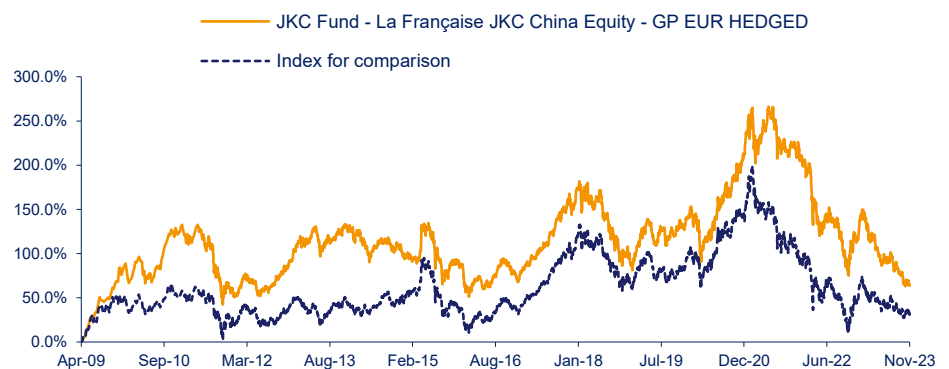

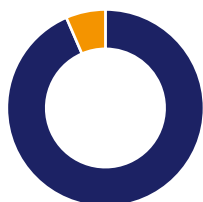

## Asset Class breakdown

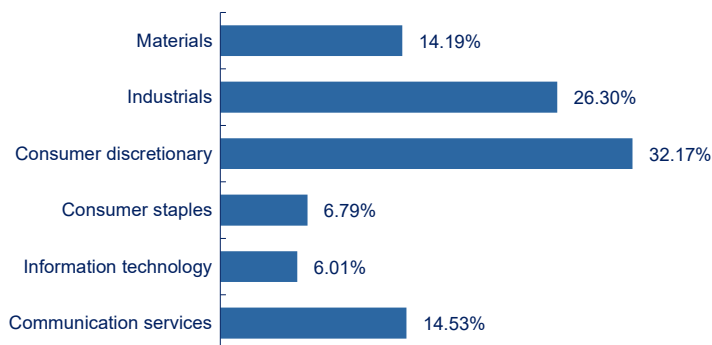

## Sector exposure (GICS classification)

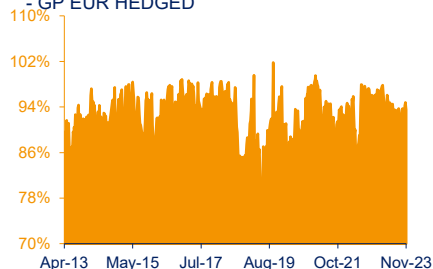

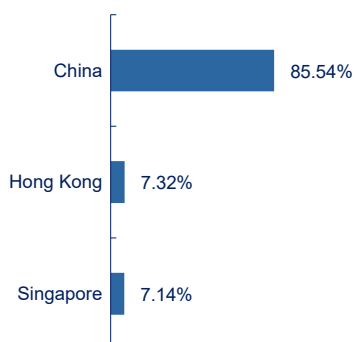

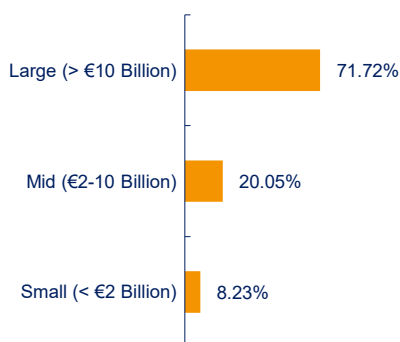
## Geographical breakdown
