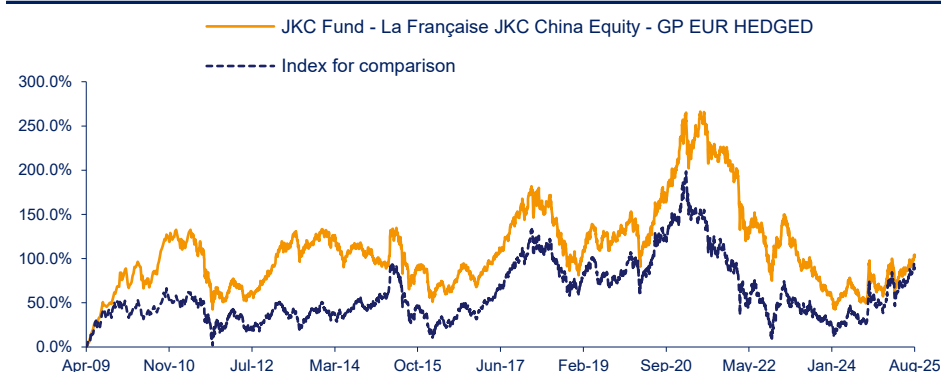

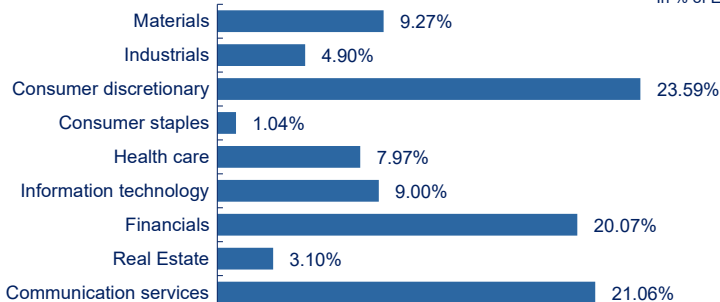

Sector exposure (GICS classification)

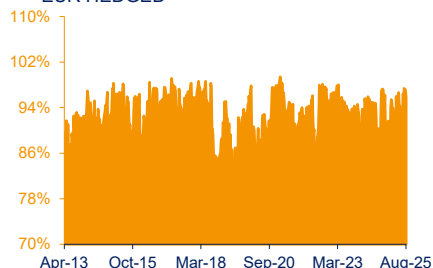

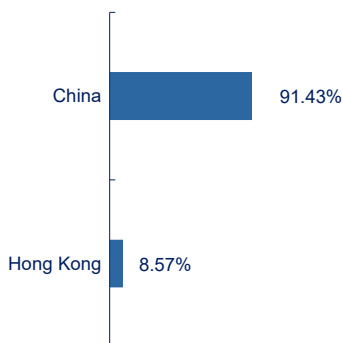

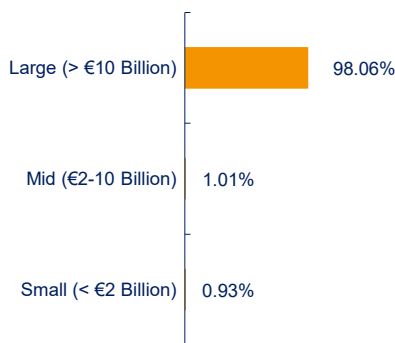
